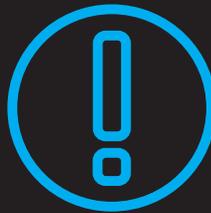


QR Code Minor incident reporting User guide

Please note:

QR Code reporting is for minor incidents only (e.g. clipping a bollard or a small bump with a third party vehicle) and should not be used to report emergencies or incidents where you require immediate roadside assistance (e.g. serious bodily harm or vehicle damage). If you require immediate assistance, please telephone **your accident management provider**, the **emergency services** in your area, or **QBE Insurance** directly on **0808 100 8181**.

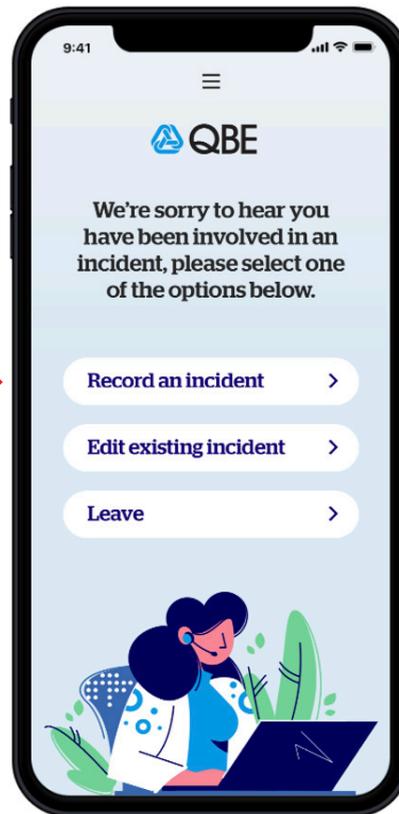

Getting started



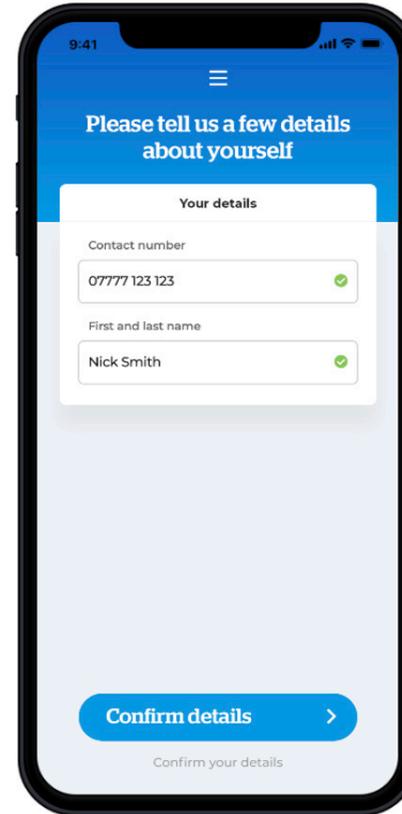
Open your smartphone camera and point the lens at the QR code in your supplied fob. A box will appear around the QR code once it has been recognised and you will be prompted to [Open "ultraincident.com"](#) in your webpage.

Press the link to start reporting your incident. (Please note the QR code shown is for reference only).

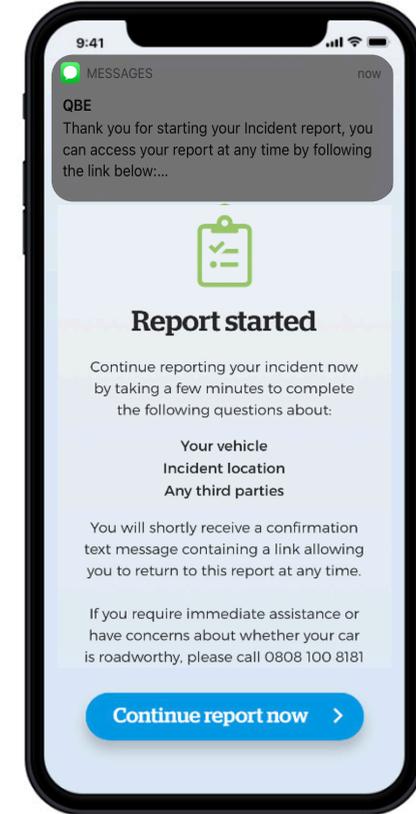


Once the webpage has launched, you will be directed to the homepage.

Select [Record an incident](#).

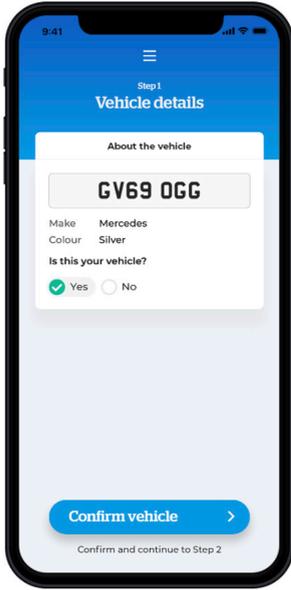


Tell us your number and name to get started. Click [Confirm details](#) to start the report.



This will start the report and you will receive a text message confirming this.

Click [Continue report now](#) to tell us key information about your incident.



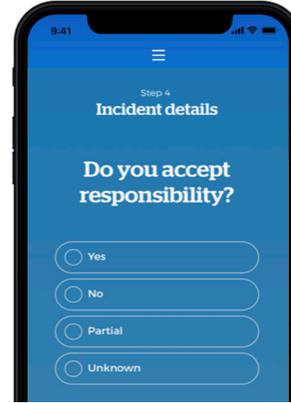
Tell us your vehicle registration number, make and colour.



Select the time and location where the incident took place.

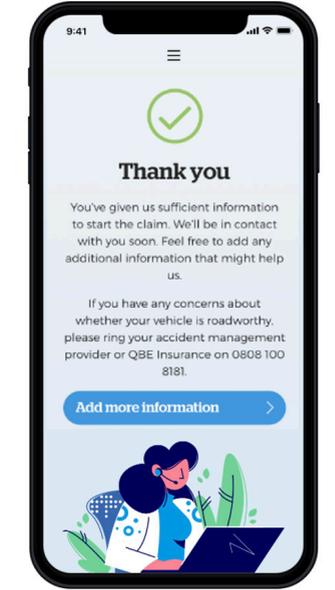
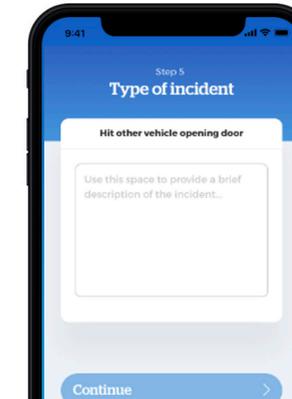
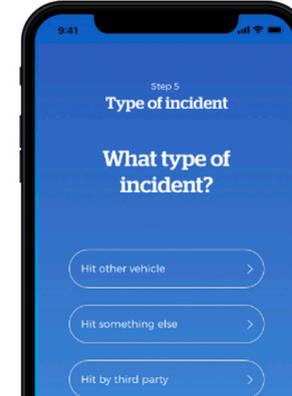
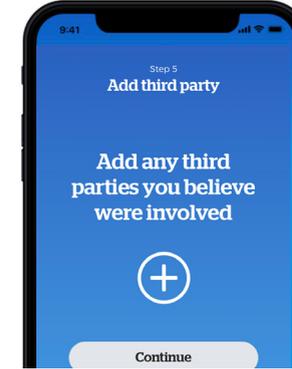


Enable location services for your phone browser to see the map on this screen.



Let us know if you accept responsibility and click **Continue**. Let us know if any third parties were involved in the incident.

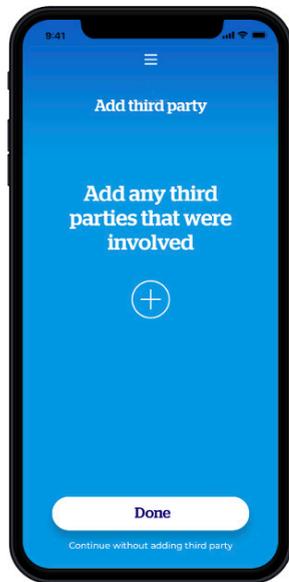

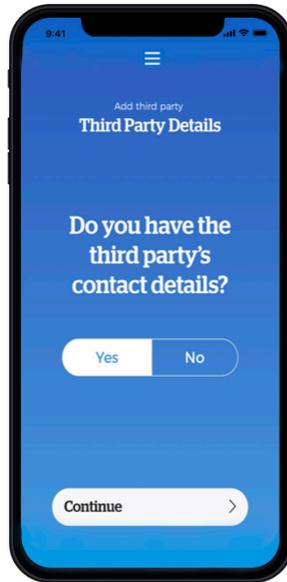
Thank you. Now we can start the claim and will be in touch with you to confirm next steps.

Adding a third party

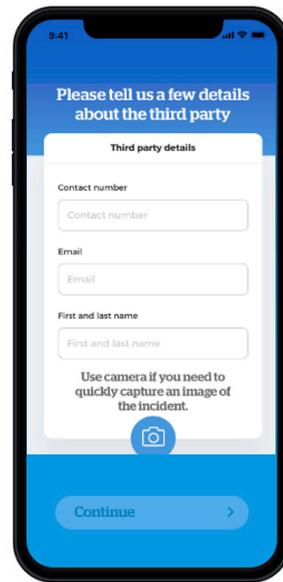


If any third parties were involved, [click the + sign](#).



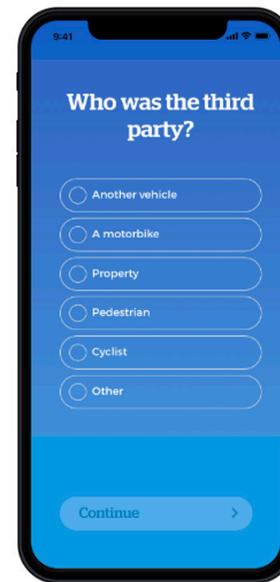
If you have the third party contact details, click [Yes](#).

If you do not have their details, click [No](#).

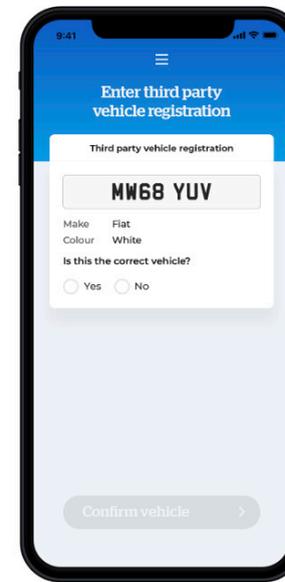


If you clicked [Yes](#) on the previous page, tell us the name and number of the third party.

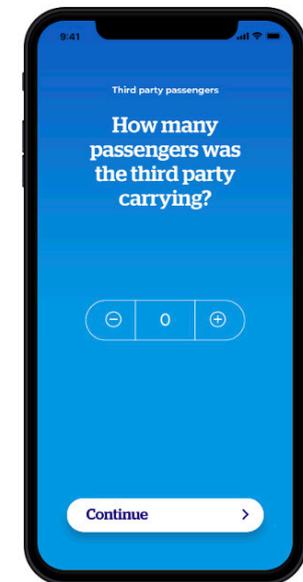
Once you have added the third party, they will receive a text message with a link to an incident form.



Let us know if the third party was driving a vehicle, bike, on foot, cycling etc.

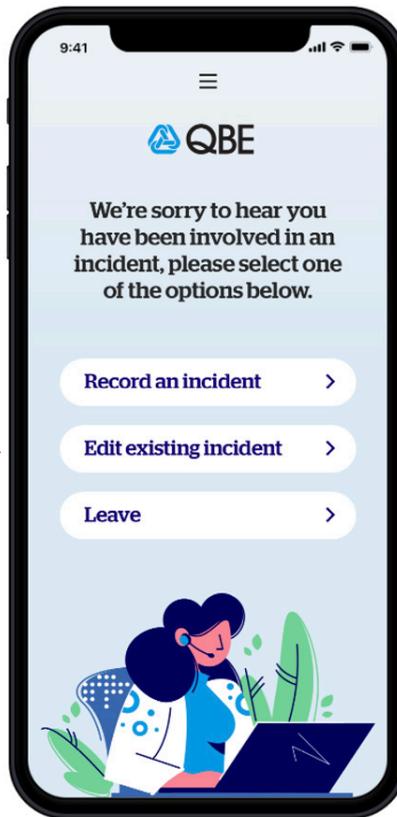


If the third party was driving a vehicle or motorbike, tell us the vehicle details if you know them.

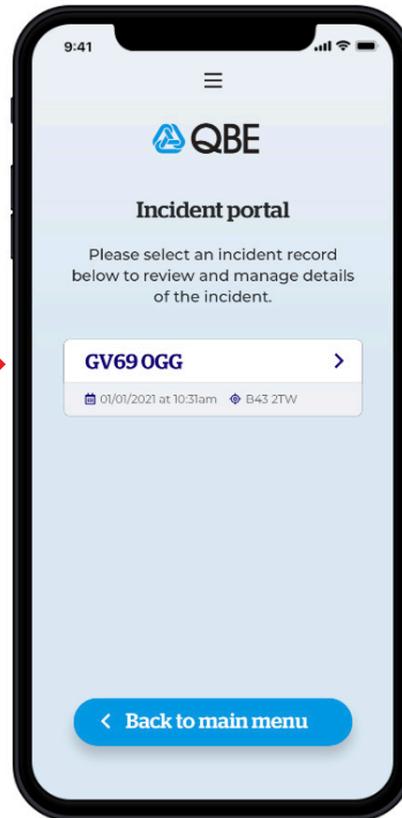


Let us know if the third party was carrying any passengers. Click [Continue](#) to confirm.

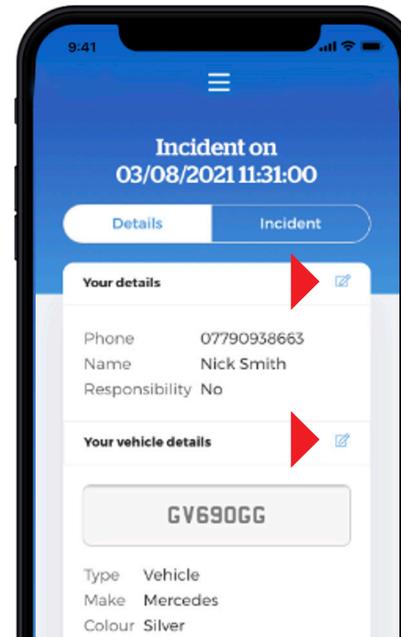
Editing your incident report



If you would like to edit an existing incident report, click **Edit existing incident**.

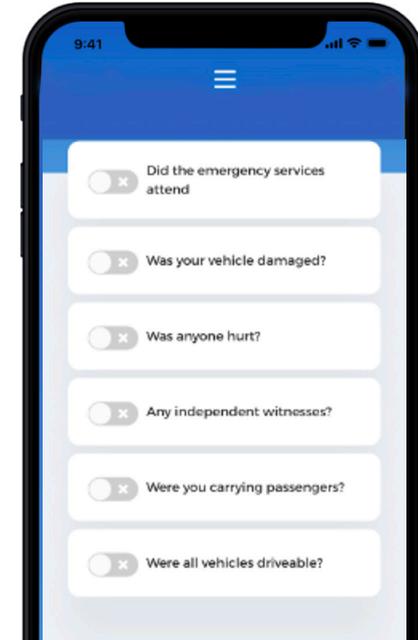


Select the incident report you would like to edit.
