Post claim products

Our Post claim products are designed to meet the needs of the claimants and policyholders, dependent on the severity of the injury and the value of the claim. From the minor, whiplash-type injuries, to complex multi-trauma, we offer the right level of service to support injured parties with their recovery.

- > Post claim Minor: remote case management for lowvalue portal claims for minor physical and psychological injuries such as whiplash and travel-related anxiety.
- > Post claim Moderate: remote case management for more complex injuries such as fractures and PTSD, that have impacted the injured party's RTW.
- > Post claim Major/Catastrophic: face-to-face case management for severe or complex injuries such as brain injuries, spinal cord injuries and amputations.

A closer look

An employee sustained serious crush injuries after heavy machinery fell on them at work. After receiving a formal Employers' Liability claim, QBE Rehabilitation obtained joint instruction with the claimant solicitor and arranged a face-to-face Immediate Needs Assessment (INA) with our panel provider. The INA identified that the injured party would benefit from private physiotherapy treatment and psychological therapy. The case manager also liaised with the policyholder to facilitate a phased RTW. The rapid access to treatment and RTW assistance expedited the injured party's recovery and RTW, saving over £28,000* in claims costs with a small outlay of approximately £3,800 in rehabilitation costs.
